Self-Select ISA Transfer Form

If you wish to transfer an existing ISA to iDealing, you will first need to register online for an ISA account and then complete and return this form to the Freepost address above.

Please note that in order to transfer an existing ISA, your current ISA Manager may require you to liquidate the existing holdings and transfer the resulting cash proceeds. Your ISA Manager will be able to tell whether this is the case. We are unable to accept unit trusts, or stocks and shares that are in liquidation and/or Crest ineligible.

From 6th April 2008, cash ISA's, including those accounts formerly known as 'TOISA's and 'TESSA's, can be transferred to a stocks and shares ISA. Cash ISA's, once transferred and accepted into a stocks and shares ISA, may not be transferred back to a cash ISA.
